Storage Period	12 months under ordinary condition at the average temperature of $15 \div 25$ °C and relative humidity of 40-60%, out of direct sunlight.	
Applications	Suitable for digital printing, OWV for inside application: for signage display, shop window advertising, building glass walls. The product is for inside windows applications, to be combined with our C-2TAPE135-30. Inside mounting avoid graffiti problems and installation costs on windows that would require scaffolding (skyscrapers). In some countries (like France), inside mounting avoid also advertising taxes.	
Compatibility of machines and inks	Media is suitable for all solvent, eco-solvent inks. Especially designed for LAtex and UV flexible inks. Inks should be the original ink from the printer manufacturers. The best printing temperature is 16-32°C. Caution with ecosolvent- PET coating media have a maximum total Ink-Limit between 100-130%. Before starting the print operation, make sure the linearization on the RIP, is fixed in accordance with the specifics of the printer on which you want to print the PET media. Notes: before laminating with double side tape C-PET135-30, be sure that the ink's drying process- polymerization is completed.
