The Company* will cover defects on High Performance Automotive Window Films Products such as adhesive failure, bubbling, cracking, peeling, delamination, demetallization** and fade to purple. The warranty is subject to the limitations herein that the written instructions and detailed descriptions of the conditions under which the Avery Dennison Products are assumed to be stored, handled, installed, used and maintained according to the instructions found in the relevant data sheets and bulletins of Avery Dennison Products, and applied to recommended surfaces.

The company will cover the costs of the purchased materials or provide a replacement product as per Avery Dennison's terms and conditions of sale. Any repaired or replaced product shall also remain subject to the warranty Period, and any repair or replacement shall not extend the original warranty Period in any manner or start a new warranty Period. INFORME DE ENSAYOS

A petición de **Avery Dennison**, se han realizado ensayos conforme a lo previsto en la **ORDEN ITC/1992/2010**, de **14 de julio**, por la que se determinan las condiciones técnicas que deben cumplir las láminas de material plástico destinadas a ser adheridas a los vidrios de seguridad y materiales para acristalamiento de los vehículos en servicio.

Se ha ensayado la lámina **AWF HP 05** adherida sobre probetas enviadas por el solicitante y que responden según dicho solicitante a las siguientes características técnicas:

- A) Nombre del fabricante o designación comercial: **Avery Dennison**
- B) Marcado del modelo dado por el fabricante: **AWF HP**



- C) Proceso de fabricación: **Tintado híbrido metalizado en combinación con tintado UV estable. Soporte PET**
- D) Número de láminas componentes que la forman: **2**
- E) Espesor nominal de la lámina: **30 micras (1,2 mil) ±20%**
- F) Color de la lámina: **Gris Grafito**
- G) Naturaleza del adhesivo: **Acrílico solvente permanente**
- H) Tipo de instalación prevista: **Interior**

ENSAYOS REALIZADOS Y RESULTADOS OBTENIDOS:

1.- ENSAYO DE FRAGMENTACIÓN:

De los ensayos realizados se deduce la equivalencia entre las roturas realizadas en las probetas con lámina y las probetas sin lámina.

2.- ENSAYO DE RESISTENCIA AL FUEGO:

De los ensayos realizados se deduce que tras quince segundos de exposición a la llama no se produce ignición de la lámina.

3.- ENSAYO DE RESISTENCIA DEL SISTEMA DE FIJACIÓN:

En el caso de láminas plásticas para instalar por la parte interna del vidrio de seguridad o material de acristalamiento, según la ORDEN ITC/1992/2010, las muestras NO se han sometido a este ensayo.

4.- MARCADO:

Se ha comprobado que sobre las probetas ensayadas, la marca de la lámina adhesiva era claramente legible e indeleble.

OBSERVACIONES:

Estos ensayos y sus resultados también son extrapolables a las láminas **AWF HP 15, AWF HP 30 y AWF HP 40** cuyas características técnicas, proporcionadas por el fabricante, son iguales y únicamente tiene un índice de transmisión de luz mayor que la muestra ensayada. Véase documentación adjunta sellada por este laboratorio.

CONCLUSIÓN FINAL

Las probetas ensayadas **CUMPLEN** con las especificaciones técnicas de la **ORDEN ITC/1992/2010, de 14 de julio**, para un tipo de instalación interna.
